The lawful basis for the processing of data is therefore: fulfilment of contractual obligations, for the purposes referred to under a); legal obligations, for the purposes referred to under b); consent, for the purposes referred to under c).

PROCESSING METHODS, DATA RETENTION PERIOD AND CRITERIA


The data will be processed in paper and digital form. The data referred to in purposes a) and b) will be processed by the Data Controllers for the period necessary to fulfil the aforementioned purposes and, at the end of these purposes, for the further prescriptive period prescribed by law relating to the storage of contracts and administrative data and/or for defence before the court (ten years from the last use and/or prescription interrupting event). The data processed for marketing purposes under c) will be processed in digital form, until consent is revoked and in any case for a maximum period of 2 years. Before the expiry of this period, the Data Controller will request new consent from the data subject and, if consent is not renewed, the data subject's e-mail contact will be deleted.

PROVISION OF DATA

The provision of data is mandatory for the execution of the contractual relationship and legal purposes, and optional for marketing purposes and subject to the consent of the data subject. Failure to provide the data will make it impossible to pursue the above-mentioned purposes.

RIGHTS OF THE DATA SUBJECT, WITHDRAWAL OF CONSENT AND COMPLAINT TO THE SUPERVISORY AUTHORITY

The data subject has the right to request access to, rectification, deletion, restriction of their personal data at any time, to object to processing and withdraw consent, and to exercise the right to data portability where possible. However, the data subject has the right to withdraw any consent given to the processing of data at any time, without prejudice to the lawfulness of the processing based on the consent given before withdrawal.

In the event of an alleged breach, the data subject, if the conditions are met, also has the right to lodge a complaint with a supervisory authority on data processing located in the EU Member State where he or she normally resides or in the EU Member State where he or she works or where the alleged breach took place.

PROFILING AND AUTOMATED DECISION-MAKING PROCESSES
