

## **INFORMATION ON THE PROCESSING OF PERSONAL DATA THROUGH VIDEO DEVICES**

### **Art 13 EU Regulation 2016/679**

In connection with the processing of the personal data provided, please note that:

#### **1. Data Controller**

The Data Controller is the company Azienda Agricola Santodeno S.r.l., with registered office in Villa Rossi 50, Civitella di Romagna, Forlì (FC) (hereinafter referred to as “the Company”).

#### **2. Type of data processed, purpose and lawful basis for processing**

The following personal data are collected and processed: non-confidential personal data (images recorded by video surveillance systems - CCTV), referring to employees, patients, third parties for the following purposes: a) organisational and production requirements.

Therefore, the lawful basis for the processing is the legitimate interest of the Controller.

#### **3. Disclosure of data to third parties - Recipients of data**

The Company may disclose the data processed for the above-mentioned purposes to i) persons and system administrators in charge with the processing of the data collected by the video-surveillance systems; ii) companies operating video-surveillance or maintenance systems; iii) law enforcement agencies; iv) consultants in the event of disputes.

#### **4. Transfer of data to Third Parties**

Data will not be transferred by the Controller to third countries. However, in the event of a transfer to third countries, this will take place in accordance with the data transfer regulations in force in each case pursuant to Article 44 et seq. of GDPR 2016/679.

#### **5. Processing methods, data retention period and criteria**

The data will be processed in digital form. The video footage is retained for 24 hours, unless it is cancelled for the protection of rights or for other legal reasons (in which case it is retained for as long as necessary to fulfil the purpose for which it was saved and, at the end of that purpose, for the further prescriptive period prescribed by law for defence before the court (10 years from the last use and/or prescription interruption event).

#### **6. Provision of data**

The provision of data is mandatory and automatic in view of the legitimate interest of the Controller.

#### **7. Rights of the data subject, Withdrawal of Consent and Complaint to the Supervisory Authority**

The data subject has the right to request access to, rectification, deletion, restriction of their personal data at any time, to object to processing and withdraw consent, and to exercise the right to data portability.

However, the data subject has the right to withdraw any consent given to the processing of data at any time, without prejudice to the lawfulness of the processing based on the consent given before withdrawal.

In the event of an alleged breach, the data subject, if the conditions are met, also has the right to lodge a complaint with a supervisory authority on data processing located in the EU Member State where he or she normally resides or in the EU Member State where he or she works or where the alleged breach took place.

#### **8. Profiling and automated decision-making processes**

Processing is not carried out by means of automated decision-making processes (i.e. profiling).
